



REGULATION FOR POSTER SUBMISSION

1. OBJECTIVE AND THEME

1.1. The presentation of posters in the scope of the International Conference “Challenges for an Active and Healthy Ageing” aims to promote the dissemination of studies and good practices in place or in development in this field of work.

1.2. Scientific Posters that address the promotion of active and healthy ageing, the promotion of healthy lifestyles, and/or the promotion of health literacy in the elderly will be considered for presentation at this Conference.

2. TECHNICAL SPECIFICATIONS

2.1. Posters should have ISO A0 size (W 841mm x H 1189mm), with portrait orientation and be single-sided.

2.2. Posters should be written in Portuguese or English, using “Open Sans” font, in a font size that allows reading at a distance of 2 meters.

2.3. Posters must use the Conference layout, available at DGS’s website

2.4. Posters must be original and unpublished.

3. JURY

3.1. The Jury will be composed of the Scientific Committee of the International Conference “Challenges for Active and Healthy Aging” which will have at least three members.

4. POSTER SUBMISSION

4.1. A digital version of the poster (pdf file) must be sent to cenie@dgs.min-saude.pt, with the subject “Poster Submission – Challenges for an Active and Healthy Ageing”.

4.2. The digital version of the poster must be submitted by June 7th, 2018.

4.3. The jury will evaluate each poster according to the following criteria:

4.3.1. Relevance of the topic in the context of Healthy and Active Ageing

4.3.2. Appropriate scientific methodology;

4.3.3. Agreement between results and methodological approach;

4.4. There will be no appeal from the Jury’s decision.

4.5. Any case here omitted shall be settled by Jury deliberation.

4.6. The Jury will communicate the results of the poster evaluation to each corresponding author by June 15th, 2018.



4.7. The results of the poster evaluation will be communicated as follows:

- 4.7.1. Acceptance of the submitted poster;
- 4.7.2. Acceptance of the submitted poster dependent on the completion of the requested revisions;
- 4.7.3. Rejection of the submitted poster.

5. EXHIBITION OF ACCEPTED POSTERS

- 5.1. The authors are responsible for printing their posters.
- 5.2. The posters must be placed in the exhibition stand designated by the Organizing Committee, by 10am on June 29th, 2018.

6. GENERAL PROVISIONS

- 6.1. A certificate will be issued to all authors of the Posters exhibited at the Conference.
- 6.2. Participation as poster author presumes the express acceptance of the guidelines contained in this Regulation.
- 6.3. The organization reserves the right to publish or reproduce the photos of the Posters exhibited at the Conference.
